





# UNIQUE JOB GRANT WITHIN LOMBARDY REGION

## SUPPORT PROVIDED FOR EMPLOYMENT OR RE-EMPLOYMENT AND VOCATIONAL QUALIFICATION OR RE-QUALIFICATION





# Unique Job Grant

## What is it?

The Unique Job Grant (*Dote Unica Lavoro*) accompanies a person through the different steps of the professional life thanks to integrated and customized services.

The person can benefit from professional and training services, in line with job-related needs.

Five categories of support have been identified and evaluated according to: distance to the labor market, age and gender.

To activate the Job Grant, it's necessary to check with a Lombardy Region approved operator in order to carry out the user profiling process and to determine the proper category.

Each category is associated to a specific Job Grant: the economic value and services are established according to the support level.

By activating the Job Grant, a Personalized intervention Plan (*PIP*) is defined in order to meet one of the following aims:

• Working integration;

Self-employment and self-entrepreneurship;

#### • Retraining (only for Category n. 5).

#### Provided services are free-of-charge.

## Who's eligible for the Job Grant?

**People under 65 years of age** can be eligible for the Job Grant; when submitting the application, they must satisfy the following requirements:

**Unemployed**, resident and/or domiciled in Lombardy Region, also Naspi recipients;

Employed but suspended people, because of a crisis, corporate reorganization or termination of productive/operational activities in Lombardy Region, also recipients of social flanking measures through the extraordinary redundancy fund (Cassa Integrazione Guadagni Straordinaria - CIGS) in the context of Solidarity Funds Institutes and/or Agreements/Contracts/Solidarity allowance as provided for in the Legislative Decree n. 148/2015;

**Employed people belonging to the police** (leaving servicepeople, military and civil personnel of the Armed Forces) resident and/or domiciled in Lombardy Region, upon prior authorization by the Command/Central Police Station/Regional Superintendency;

**People enrolled in a first or second level Master's Degree Course** resident and /or domiciled in Lombardy Region;

The following persons are excluded from the above target groups as recipients of other active policy measures:

Young people under 29, who may benefit from the "Garanzia Giovani" (Youth Guarantee) measure.

**Employed but suspended people involved in Reallocation Agreements**, art. 24 bis Legislative Decree 148/2015 and benefiting from the Re-allocation Allowance and the "*Azioni di rete per il lavoro*" program.

Pursuant to Legislative Decree n. 150/2015, unemployed people must issue the *"Dichiarazione di Immediata Disponibilità al lavoro"* (statement of immediate willingness to work) and agree upon a *"Patto di servizio* 

Support Categories

*personalizzato*" (personalized service pact) before activating the Unique Job Grant.

**Employed but suspended people** pursuant to the former art. 22 of the Legislative Decree n. 150/2015 must agree upon the *"Patto di servizio personalizzato"* (personalized service pact).

## Which are the support categories?

According to the recipient features, the information system automatically defines the relevant category:

#### Category 1 "Low"

people desiring a basic guidance support to autonomously re-enter the labour market;

#### Category 2 "Medium"

people needing more support to autonomously search for a new job or to establish a long-lasting business relationship;

#### Category 3 "High"

people needing an intense support in order to search for a new job;

#### Category 4 "Very high"

people needing an intense support to enter/reenter labour market after a long unemployment period;

#### Category 5

"Different Support"

people needing professional re-qualification or employability services.

# CATEGORIES from 1 to 4

People eligible for the first 4 categories of professional and training services:

**Unemployed people** (Categories from 1 to 4 according to the user profiling outcomes);

**Employed but suspended people** (Category 3 according to the user profiling outcomes) benefiting from social flanking measures through the extraordinary redundancy fund (*Cassa Integrazione Guadagni Straordinaria - CIGS*) and from Agreements/Contracts/Solidarity allowance (in case of crisis or corporate reorganization with redundancy prevision).

# **CATEGORY 5**

People eligible for training services within Category 5:

**Employed but suspended people** benefiting from social flanking measures through the extraordinary redundancy fund (*Cassa Integrazione Guadagni Straordinaria - CIGS*) and from Agreements/Contracts/ Solidarity allowance (in case of crisis or corporate reorganization without redundancy prevision) and people with Solidarity Contracts without redundancy prevision;

People belonging to the police;

People enrolled in a first or second level Master's Degree Course in a University within Lombardy Region;

Other persons identified by the Regional Office, under specific requirements.

## How long does the Job Grant last?

The Job Grant lasts differently according to the Category:

Category 1, 2, 3 and 5: 180 days

## Category 4: 360 days

#### After the Job Grant has expired

The recipient of the Category 1, 2 and 3 unable to attain the employment result, can be eligible for a new Job Grant in order to achieve the aim.

# Which services does the Job Grant offer?

According to the Category and to the final aim to achieve, the person can benefit from several professional and training services.

What should I do to apply for the Unique Job Grant?

In order to apply for the Unique Job Grant, it's necessary to check with an approved operator.

The recipients of Category 5 belonging to the police or enrolled in a first or second level Master's Degree Course should check with an Authorized Training Body or with a University within Lombardy Region.

### What does the approved operator do?

The operator receives the person and use the regional information system to:

- **Fill in the user profile** (biographical data, employment situation, etc.)
- Assess that the person meets the requirements to activate the Job Grant
- Evaluate the support Category

The approved Operator

• Verify the accessible services

 Define the Personalized Intervention Plan, signed by both parties (citizen/representative of the authority); a copy of the Plan is supplied to the recipient.
